Certification of Non-Resident Status

[__] 2. Takes the position that the undersigned is not a resident of Connecticut, New Jersey or New York for income tax filing purposes; provided that such position is not disallowed by the relevant state.

The undersigned shall promptly advise WRT if the criterion being relied upon for eligibility of Non-Resident Member status is no longer satisfied for any reason including in the case of 2 above, the disallowance of such position by the relevant state. In such case, the undersigned shall be responsible for payment of the undiscounted dues commitment applicable to Resident Members for the relevant period.
